六．必須遵守本會執行委員會不時修訂的其他條件。七．填妥申請表格及邀請其他機構會員之正式代表為動議及和議人；八．將申請表格，支票及有關文件寄回 九龍新蒲崗大有街32號 泰力工業中心 3樓3室 香港電池業協會；九．業務總監(業界發展)/總主任(會員聯繫及服務)及主任將進行機構探訪，並將有關申請提交執行委員會考慮，並於三十日內以書面通知有關結果。

According to HKBIA Council's Constitution, organizations wishing to apply for Agency Membership must fulfill the following criteria:

1. They should be a registered company or corporation or registered society in Hong Kong; 2. They must be recognized by the Council as battery industry related; 3. They must have been in operation for a period of at least two years; 4. They must possess a document of registration of the company or corporation or registered society; 5. They must make available their Annual Report and Audited Accounts or certified accounts with regards to annual income and expenditure; 6. They must comply with such other conditions as may be prescribed by the Executive Committee from time to time; 7. Please completed the application form included the cheque or deposit slip and send it to HKBIA, we will process your application in 5 business days; 8. Complete the Application Form and invite the official representatives of other Agency Members for the nomination of Membership Application; 9. Send the Application Form with the required application documents to “Hong Kong Batteries Industry Association” Room 3, 3/F, 32 Tai Yau Street, Laurels IND Center, San Po Kong, Kowloon, Hong Kong ; 3. Business Director (Industrial Development)/Chief Officer (Membership Liaison & Service) and Officer of the Council will visit the agency and the application will be submitted to the Executive Committee (ExCo) of the Council for consideration. Applicants will be notified in writing within 30 days after ExCo's endorsement. (Application fee: \$500, Membership annual fee \$1500, Heng Sang Bank account# 799—048335-001, Annual membership valid till March 31st )
